## Plaintiffs' Motion for Summary Judgment

Pursuant to K.S.A. § 60-256, Plaintiffs respectfully move the Court to grant them summary judgment on the first claim for relief asserted in their Petition: that HB 2253 (2013-14 Session), 2013 Kansas Laws ch. 119, (the "Act") violates Article 2, § 16, of the Kansas Constitution. In support of this motion, Plaintiffs rely on the Act itself, annexed hereto as Exhibit A, and the memorandum of law submitted herewith.

## WHEREFORE Plaintiffs request that the Court:

- a. grant this motion for summary judgment;
- b. issue a declaratory judgment that the Act as a whole is unconstitutional and therefore unenforceable;
- c. issue a permanent injunction restraining Defendants, their agents, and their successors in office from enforcing the Act in its entirety or any provision thereof; and

d. grant such other and further relief as the Court deems just, proper, and equitable.
