Rebuilding Abortion Rights in the United States

In a devastating decision that will reverberate for generations, the U.S. Supreme Court overturned Roe v. Wade and eliminated the constitutional right to abortion. The Supreme Court's ruling in our case, Dobbs v. Jackson Women's Health Organization, abandoned nearly 50 years of precedent and marked the first time in history that the Supreme Court has taken away a fundamental right, allowing elected officials to severely restrict or ban abortion. With the ruling, the U.S. became an outlier to the decades-long global trend toward liberalization of abortion laws.

Within days of the Supreme Court's ruling, we took action, suing in state courts to block abortion bans that had been previously unenforceable under *Roe*. We also worked with our partners to advance proactive state legislation, enhancing protections for abortion access across state lines, and to support state ballot initiatives, a key strategy for strengthening abortion rights under state constitutions. Working with the Biden administration, we helped advance federal policies to improve access to abortion care, and we continue to advocate for federal legislation, such as the Women's Health Protection Act, to protect and preserve access to care nationwide.

We will continue to use all legal levers to fight against abortion bans and restrictions and to build a stronger legal framework to ensure everyone, in every U.S. state, can exercise their right to reproductive autonomy.

Advancing Abortion Rights and Adolescents' Rights in Africa

We have secured impactful court decisions to build and strengthen legal protections for sexual and reproductive health and rights in Africa.

In a victory for Kenyan women, girls, and health care providers, the High Court of Kenya in Malindi affirmed the right to abortion under the 2010 Kenyan Constitution and directed parliament to amend the penal code to align with the Constitution and to protect abortion access. The Court also ruled that arbitrary arrest and prosecution of people who seek or provide abortion care are illegal. We brought this case with our partner, the Reproductive Health Network Kenya (RHNK), on behalf of a

minor who sought emergency abortion care and the clinician who treated her, both of whom were arrested and detained. The ruling will help protect access to reproductive health care across the country, free from threats and harassment.

In Tanzania, a historic ruling found that the government's practice of forcing girls in public schools to undergo pregnancy testing and

permanently expelling them if pregnant violated their human rights. In its decision, the African Committee of Experts on the Rights and Welfare of the Child (ACERWC) recommended that Tanzania end the longstanding practice and reform its education policies, a victory that will impact adolescents across the region. Tanzania's Minister of Education had previously announced an end to the discriminatory practice. The ACERWC ruling in our case, brought with the Legal and Human Rights Centre of Tanzania, will ensure lasting change.

Building Stronger Maternal Health Protections in Pakistan

In a major advance for maternal health, women in the Sindh Province of Pakistan now have access to repair services for obstetric fistula free of cost. A case conceptualized by the Center's South Asia Reproductive Justice and Accountability Initiative (SARJAI) secured a 2019 ruling from the Sindh High Court ordering the government to increase access to this type of care. Since then, we have worked to ensure that the decision was implemented, and the Sindh government has taken significant steps, including staffing government hospitals with gynecologists and establishing fistula repair centers. The High Court issued its final order in December 2021 taking note of this progress.

in Pakistan are now living under stronger legal protections for reproductive rights The maternal mortality rate in Pakistan remains alarmingly high and we are advocating to hold the government accountable, including before the United Nations. With our Karachi-based partner Aahung, we are calling on the Pakistan government to implement laws and policies that protect the right to access obstetric care services, especially

for underserved communities. We are also urging the government to ensure access to contraception and safe abortion and to promote adolescents' sexual and reproductive health and rights.

Strengthening Reproductive Rights in Latin America and the Caribbean

Across Latin America and the Caribbean, historic legal victories and the powerful Green Wave movement have helped deliver meaningful progress on sexual and reproductive health and rights.

In a landmark ruling, after nearly a decade of litigation, the Inter-American Court of Human Rights for the first time established standards for the region to help protect people seeking reproductive health care, including abortion. The Court—the highest judicial body for human rights in the Americas—found that El Salvador had violated the human rights of our client, Manuela, who experienced an obstetric emergency

and was unjustly sentenced to 30 years in prison because of the country's total abortion ban.

Under the Court's ruling, health care staff can no longer refer women to law enforcement for seeking reproductive health care. The decision will apply to countries throughout the region, and it has already contributed to the release of other Salvadoran women from prison.

In another important victory, Colombia's Constitutional Court ruled to decriminalize abortion up to 24 weeks of pregnancy—the most advanced abortion regulation in the region. As part of the Causa Justa movement, we brought this case before the Court to eliminate abortion as a crime, to reduce barriers to access, and to end the risk of criminal prosecution for those seeking or providing abortion care. The case provided an opportunity to change the public conversation around abortion and overcome stigma. This decision in Colombia, together with recent advances in Argentina and Mexico, has become a reference for the reproductive rights movement in the region.

Addressing the Sexual and Reproductive Health and Rights of Refugees from Ukraine

With nine national civil society partners, we launched a new initiative to address the urgent sexual and reproductive health and rights (SRHR) and gender-based violence (GBV) support needs of women and girls impacted by the war in Ukraine. The vast majority of refugees fleeing the invasion are women and children and many are facing grave threats to their health and rights, including GBV and a lack of access to essential sexual and reproductive health care. We are identifying and addressing barriers in access to care—including abortion, emergency contraception, and maternal health services—as well as barriers in access to GBV support services that refugees are facing in Hungary, Poland, Romania, and Slovakia, and we are providing institutional and operational support to frontline organizations on the ground. The initiative is also addressing the challenges facing SRHR organizations and human rights defenders in Central and Eastern Europe that are providing support to refugees.

With partners, we are conducting evidence-based documentation of the SRHR and GBV support needs and barriers faced by refugees and advancing advocacy strategies with governments, the European Union, other international bodies, and humanitarian actors to inform their response to ensure women's SRHR needs are prioritized.




Advancing Abortion Access as a Human Right and Public **Health Imperative**

The World Health Organization (WHO) issued its new Abortion Care Guideline, affirming abortion access as essential to health and human rights and calling for the removal of legal barriers to access. The guideline is WHO's definitive recommendations to governments, health systems, and law and policymakers on abortion care, and it replaces the organization's previous guidance on abortion. Drawing on the latest scientific evidence and data, the guideline provides more than 50 recommendations on abortion law and policy approaches, clinical management, and service delivery for states and health systems to follow.

We were a part of WHO's Guideline Development Group of experts on abortion issues who worked for two years to weigh all the public health evidence and human rights considerations and make recommendations. We also developed a fact sheet to highlight the seven law and policy recommendations in the Abortion Care Guideline and summarize the evidence used to support each one. Our fact sheet, a key advocacy tool and resource for partners and policymakers, lifts select core themes that are weaved throughout the new guideline, including inclusivity, autonomy, and self-management.

Financials

Our financial growth over the fiscal year ending June 30, 2022, allowed us to expand our impact around the world. Total revenue raised was \$55.3 million, and we received additional in-kind support valued at \$32.1 million, mostly for legal services. Seventy-eight percent of our expenses went directly to program.



Based on the Generally Accepted Accounting Principles (GAAP), our audited financial statements for fiscal year 2022 reported total net assets at the close of the fiscal year were \$80.8 million and the total recognized revenue was \$94.8 million inclusive of donated services.

Pro Bono Partners

We are deeply grateful to our pro bono partners who contributed legal services valued at \$32.1 million this fiscal year—an increase of \$3 million over the previous year. Through our Pro Bono Program, we worked with 1,034 dedicated law firm attorneys from 44 countries. Their enduring commitment to our mission has made an important impact in our work around the world.
