
ORDER

Appellees' Motion to Strike Plaintiff-Appellant's Supplemental Brief and Motion to Dismiss Appeal is granted. The appeal is dismissed. See Okla. Sup. Ct. R. 1.6(c)(1). Appellant is no longer an active domestic limited liability company in the State of Oklahoma and, thus, lacks good standing to maintain the present action. See 18 O.S.2021 § 2055.2. The temporary injunction against enforcement of Oklahoma House Bill 1721 (HB 1721, 2015 Okla. Sess. Laws, Ch. 59) is lifted.
